If your plans change, the entry fees (checks) will be destroyed as long as 24-hour notice is given to the Race Administrator prior to registration. CMAC will be happy to bundle bibs for visiting coaches to pick up at registration. Please advise the Race Administrator no later than January 21st. Racers may be entered as a group if separate entry forms are used for each racer and ALL INFORMATION, FEES, BIB DEPOSITS AND DOCUMENTATION ARE COMPLETE.
