Rules:

1. The competition shall be governed by the USSA Rules and Regulations.
2. USSA license is required
3. The Dual Mogul event will be seeded from the results of a one run Mogul event held in the morning before the Dual event.
4. Registration is available Sat and Sunday morning, see registration below.

Entries:

Entry fees are \$45.00 for J3 and above and \$35.00 for J4 and under.

Fees are payable by cash, personal check, or bank card.

Registration:

All team captains should e-mail a list of participating athletes to LC@skiwhitepass.com by Wednesday January 25. Registration and bib assignment will take place each day from 8:00-9:00 am in the Sitzmark Lounge in the top floor of the Day Lodge.

Lift Tickets:

Lift tickets are available at the White Pass Ticket booth daily. Single day, two day or three day (Fri, Sat & Sun) passes may be purchased at a discounted rate. Juniors ages 12 years and under the cost is \$21. per day. For those 13 years and older the cost is \$31. per day.

Bibs:

All competitors must wear their bibs during official training, competition, and award ceremonies. A deposit of \$40. Per bib will be charge upon assignment for those that are not wearing their own bib.

USSA Membership: All competitors must be ussa licensed, no exceptions. USSA membership may be purchased at registration with full payment and proof of medical insurance. Only a Parent or legal guardian may sign for a minor.

Liability Release: Signed Liability release must be on file or submitted at registration. Release may only be signed by minor's parent or legal guardian.

Course Review: The Mogul course review will be held from 9:15 – 9:45 am Saturday. Course may be viewed from the east side or the at the finish area. **Slopestyle** course training/review will be held 9:00 – 10:30 am Sunday. The slope-style event is held in the terrain park located on the far-east face.

Awards: Awards will be offered to the over-all man and woman in each event, 1st, 2nd and 3rd place winners are awarded.
